OFFICE ORDER

The Khyber Pakhtunkhwa Right to Information Commission, Peshawar invited open tenders for printing of registers for the use of Public Information Officers (PIO's) as per proforma devised by the Commission. On behalf of **M/s Professional Printing Press, Amin Mansion, G.T Road, Peshawar**, Mr. Hameed Ullah submitted tenders for printing of 1000 registers at Rs. 88.86/- per register and the Purchase Committee, after deliberation and negotiation with the bidders, approved his bid and Terms of References (TOR's) were signed by the parties. Accordingly, work order/supply order was issued in favour of the Contractor on **06th July, 2015**, for the supply of the said number of registers within the agreed time of ten days. The Contractor supplied only 57 registers upon which he was given various notices including final Show Cause Notice issued by this Commission vide No. **AO/RTI/6-1/2016/4066**, dated: **17th April, 2016**, warning the contractor to appear before the Commission and explain as to why his call deposit amounting Rs. 3300/- should not be forfeited. The Contractor appeared before the Commission on **26th April, 2016**, and undertook to provide the rest of 943 registers on **27th April, 2016**. Instead the contractor supplied only 201 registers by **28th April, 2016**. It has been observed that despite repeated requests/reminders, the supply of the registers could not be completed nor any valid reason has been shown for the non-supply of the registers according to the signed contract.

In the circumstances, this Commission has decided to forfeit his call deposit amounting to Rs. 3300/- and blacklist the said firm from dealing with the Right to Information Commission for three years. The supplied registers are not of the same quality as per sample which was brought to this Commission before the contract was signed. Therefore, the Contractor is directed to lift the supplied registers within **one week** failing which the Commission will destroy the same at the risk and cost of the Contractor.
