1. FACTS OF THE COMPLAINT:

- i. Brief facts of the case are that a citizen/ complainant namely Dr. Naseem Akhtar sought information about the HEC letter for the promotion of the existing regular Lecturers in BPS-18 to the post of Assistant Professor (BPS-19) under Tenure Track System being approved by the 14th meeting of the selection Board which was held on August 25, 2015 wherein HEC advised the University regarding the Additional Agenda Item No. 11 and Page 4 of promotion of BPS-18 (few lecturers) to TTS-19 Assistant Professor from the Shaheed Benazir Women University, Peshawar here after referred as Public Body.
- ii. The complaint was examined by the Commission vis-à-vis the various provisions/sections of the KP RTI Act 2013, and decided to direct the Public Body to provide the concerned letter to the complainant under intimation to the Commission.
- iii. Incompliance, the Public Body replied to the Commission vide there letter No. 767/LegRtiR-Meet/Reg/SBBWUP Dated: Wednesday 27th, 2023 which was shared with the complainant vide the Commission letter No. RTIC/AR/1-10597/2023/2098-21100 Dated: 17-10-2023. However,

the complainant showed her dissatisfaction to the reply of the Public Body.

- iv. A series of correspondence was made between the Public Body and the Commission but to no avail. This warranted personal hearing in the instant complaint on 24-04-2024.
- v. Incompliance, Deputy Registrar (Estt)/PIO attended the Commission and appraised the Commission that no advertisement has been floated by the Public Body about the above referred Lecturers rather the Public Body through selection board promoted the above referred Lecturers to Assistant Professors.
- vi. Accordingly, the Public Body vide their letter No. 37(Estb)/PIO/2024 Dated: 29-04-2024 submitted a concise reply.

2. OBSERVATIONS OF THE COMMISSION:

 The Commission observed that the role of the Commission is to balance the provision of information as mandated by the act ibid. and to share the information in matters of public importance.

3. DECISION:

 In view of the above the Commission decided to share the above referred concise statement/reply with the complainant and dispose of the instant complaint accordingly.

- ii. The complaint was examined by the Commission vis-à-vis the various provisions/sections of the KP RTI Act 2013, and decided to direct the Public Body to respond to the Commission.
- iii. The Public Body vide their letter No. <u>DDC/13951</u> Dated: 16-11-2023 informed the Commission that "the Directorate has already communicated the findings of Fact Findings enquiry report with the applicant/complainant".
- iv. Consequently, the Commission shared the same with the complainant vide its letter No. <u>KPIC/AR/1-10693/23/22808-10.</u>
- However, the complainant requested the Commission vide his letter received vide diary No. 11463 Dated: 27-12-2023

that he required all the Inquiry Proceedings, Statements and Findings.

- vi. This warranted the Commission to issue personal hearing notice to the public body in the instant complaint to explain the factual position on 24-04-2024.
- vii. Incompliance, Deputy Director (complaints) attended the Commission and appraised the Commission that there the outcome of the concerned inquiry has already been shared with the complainant. However, as far as a copy of the inquiry report is concerned there are personal grudges going on between the officer concerned and the complainant and the officer has informed the Public Body to this effect that she is facing life threats.

2. OBSERVATIONS OF THE COMMISSION:

- The Commission observed that the role of the Commission is to balance the provision of information as mandated by the act ibid. and to share the information in matters of public importance.
- ii. The Commission also observed that since the outcome of the inquiry proceedings has already been shared with the complainant therefore, the Public Body needs to further elaborate the stance of the officer concerned in writing so as to decide the matter under the Act ibid.

- 8. How many vehicles are used by the Excise police station in Peshawar and Mardan region are these confiscated vehicles?
- ii. The complaint was examined by the Commission vis-à-vis the various provisions/sections of the KP RTI Act 2013, and decided to direct the Public Body to submit parawise reply to the Commission. A series of correspondence were made between the Public Body and the Commission. However, the Public Body responded vide their letter No. 8953/Estb./Information Commission Dated: 13-02-2024 "that the preparation of report is a time consuming process and under process".
 - iii. This warranted personal hearing in the instant complaint on 24-04-2024.

2. OBSERVATIONS OF THE COMMISSION:

- The Commission took serious notice of the non-attendance of the personal hearing on the part of the Public Body by the PIO concerned.
- ii. The Commission also observed that the RTI request is simple and clear as the complainant has sought only data and rules of the Public Body in para 5.

3. DECISION:

 In view of the above, the Commission decided to bring the noncompliance of the Commission's direction into the notice of the Administrative Secretary of the Public Body i.e. Secretary Excise and Taxation for procedural lapses in the Public Body.

Incompliance, Planning Officer/PIO of the Public Body along with the Deputy Secretary attended the Commission on 24-04-2024 and appraised the Commission that though the enquiry has been finalized and submitted to the quarter concerned for implementation. However, the same would be shared with the Commission if so desired.

2. OBSERVATIONS OF THE COMMISSION:

- i. The Commission observed that the exemption/exception claimed by the Public Body in the above referred letter is not maintainable as the concerned enquiry has been finalized and submitted for implementation to the quarter concerned as well.
