1. FACTS OF THE COMPLAINT:

- i. Brief facts of the case are that a citizen/ complainant namely Dr. Khalid Khan sought information from the Department/ Public Body Khyber Pakhtunkhwa Directorate General of Science & Technology, Peshawar here after referred as Public Body sought information about the contact details and addresses of the houses of the then Director Mr. Sajjad Hussain Shah.
- ii. The complaint was examined by the Commission vis-à-vis the various provisions/sections of the KP RTI Act 2013, and decided to direct the public body to provide asset declaration form of the officer concerned to the Commission. A series of correspondence were made between the Commission and the public body for the provision of information but the public body failed to present any plausible reply which warranted the Personal Hearing in the instant case. Thus; the Commission issued Personal Hearing notice to the Assistant Director (M&E)/PIO to explain the factual position which was attended by the PIO concerned of the public body.
- iii. The Public Information Officer (PIO) of the Public Body apprised the Commission that the matter has already been taken up with the DG concerned being the head of the directorate who has responded that the information is exempted under the Section 16 of the KP RTI Act, 2013.

In view of the above, the Commission decided to forward the case of non-compliance to the Secretary ST&IT Department to intervene into the matter as being the Administrative Secretary the responsibility vests on the Secretary concerned to obtain the requisite information from the quarter concerned and submit to the Commission for examination and decision within seven working days positively.






